For chromium(VI), it is stated that chromium(VI) is highly toxic. It is absorbed through both the lungs and the gastrointestinal tract. Chromates/dichromates can act as strong oxidising agents, causing burns and ulcers on skin and mucous membranes as well as irritative symptoms in the upper respiratory tract. After the substance enters wounds, poorly healing ulcers appear. In sensitive individuals, the substance can easily lead to sensitisation and allergic reactions in the respiratory tract (risk of pneumonia!) and damage to the nasal mucosa (possibly septum perforation). After ingestion of the substance: severe discomfort in the gastrointestinal tract such as bloody diarrhoea, vomiting (aspiration pneumonia!), cramps, circulatory failure, loss of consciousness.
